#### Children's Breakfast Launches A County-Wide Prevent-A-Thon





On March 30, 2011 The Children's Advocacy Center and Children's Protection Council hosted a Children's Breakfast to introduce Prevent Now, a community prevention initiative and to launch our Prevent-A-Thon. The breakfast brought together 127 leaders from our faith, business and civic communities. Attendees learned about the problem of child sexual abuse, the human and economic impact for our community, and best of all that we can prevent child sexual abuse.

Catawba County's Prevent-A-Thon will provide a significant focus on the prevention of child sexual abuse through the evidence based *Stewards of Children* training curriculum. Our goal is to train 6,000 adults over the next five years. By training 6,000 adults we will reach "tipping point" which means we will begin to see behavior changes in adults that will ultimately result in a change in societal values.

At the breakfast we received commitments from over 65 churches and businesses to provide a venue for the training. This will allow us to saturate the community with training opportunities at various times and locations throughout

The banguet was established in 1980 in honor of Dr. Millie Hancock Schumpert, retired Hickory physician, and Jean Settlemyre Tashman, retired administrator of Frye Regional Medical Center. The award was named for the women as a way to recognize their contributions to the community in promoting awareness and prevention of child abuse and neglect. Each year an individual, community group, or business who has worked to enhance the quality of family in Catawba County receives the Hancock-Settlemyre award. during the Hancock-Settlemyre Banquet. The quilt is made from T-shirts with each shirt bearing the name of a child who died in North Carolina as a result of abuse or neglect. This year the quilt was crafted by Linda Henson, mother of Karen Brown who is the Mental Health Therapist at the Children's Advocacy Center. Each panel holds a T-shirt made by members of the Hickory High Art Club. During the presentation of the quilt, Linda told the attendees, "I wanted to create a quilt which represented a symbol of peace. I showed the quilt to my quilt guild and there were lots of tears shed

as I told them about the quilt." Linda sewed the words "In the Arms of Angels" into the top border, and angels are beautifully stitched all around the window pane pattern.



### **Director's Update**

#### I have the wonderful opportunity to facilitate our non-offending parent support and education group. As the name indicates the group is made up of parents or another caregiver who is now left with the difficult task of picking up the pieces in the aftermath of child sexual abuse. What we know through research and direct observation of the children we serve is that a supportive parent is the most important person in a child victim's journey to healing. It has been an honor to journey with these moms, dads, grandmothers and other caretakers as they learn how to best support their child as well as take care of themselves. For these women and men it is a difficult journey their child has been sexually perpetrated and more times than not – by someone they trusted. So we spend ten weeks learning and talking – we learn facts about child sexual abuse but mostly we talk about how to support child victims of sexual abuse. One of our volunteers, who co-facilitates the group with me, said something during one of the sessions that took me and the group by surprise. She told the group, "You are the lucky ones." I snapped my head in her direction, and just as I was about to say, "What do you mean, lucky ones?" this wise woman continued to explain how so many children never tell and they are the children who grow up to be one of the statistics we read about. "But your child told, no matter who they told or how they told...they told. The secret is out. With your support and with the help of the CAC staff your child will be ok. They do not have to grow up to be a statistic." I have heard Kelly say that a dozen times to as many groups over the past four years. I never tire of hearing her words. Children can and do heal from child sexual abuse, and each time I hear Kelly say these words I am reminded of why we exist and of the important work we do. We offer a ray of sunshine, a ray of hope to the children who are brave to tell their story. Thanks to all of you who volunteer in any capacity to help offer hope. Deb
