Pinwheels for Prevention is a national campaign that uses pinwheels as a symbol to raise awareness about child abuse prevention. In April, volunteers planted **1,884 pinwheels** that were sponsored by community members.

As a part of our commitment to prevention efforts, we partner with **Darkness to Light** to offer **Stewards of Children**® trainings for adults across our community. In local schools, we offer trainings for children by the **Monique Burr Foundation for Children**.

Research shows that at least 1 in 10 children will experience sexual abuse before they turn 18, and <u>only 10% of those children ever tell someone.</u> An adult speaking up can be the first step in protecting a child and potentially saving a life. It's not just a moral responsibility—it's also the law.

During National Child Abuse Prevention Month, the Children's Advocacy & Protection Center's Prevention Council launched a Mandated Reporting Awareness Campaign, reminding the community that every adult in North Carolina is a mandated reporter of child abuse. **More than 500 copies** of the campaign materials were distributed throughout Catawba County, reaching schools, churches, daycares, businesses, doctor's offices, churches, nonprofits, and libraries. The message was also shared widely through social media, email, and even included in city water bills.

The mandated reporting campaign's impact also spread statewide through the **Children's Advocacy Centers of North Carolina**, highlighting the power of collaboration and community partnership in protecting children.


Clinical & Forensic **Services**




The Children's Advocacy and Protection Center delivers a comprehensive range of clinical and forensic services designed to support child victims and their families.

Child & Family **Advocacy**

Our Child and Family Advocate, MeLissa Swartley, supports children and non-offending caregivers through the forensic interview and court process. She provides emotional support, explains each step, and connects families with resources for healing. MeLissa says that "Many parents and caregivers often feel alone and are not sure where to turn when their child discloses abuse. Enter HOPE Class."

Did You Know...?

- 1 in 4 girls and 1 in 6 boys will be sexually assaulted before the age of 18.
- **90% of child sexual abuse** is committed by relatives, close family friends or an adult that the child knows and trusts.
- **301 children** were interviewed at our Center this year for allegations of abuse.

HOPE CLASS

In HOPE Class, caregivers:

- Gain an understanding of the effects of child sexual abuse
- Learn how to recognize the signs of abuse and how to protect children
- Learn about resilience
- Gain parenting insight
- Give and receive support from others with similar experiences
- Share concerns and triumphs
- Support the child


HOPE Class meets for 7 weeks with meals, curriculum, childcare and gas vouchers provided at no cost to the caregiver. Caregivers who completed the most recent class shared their appreciation, with one saying, "I am thankful for this opportunity to gain more knowledge... before this class I had lots of questions," and another saying, "This kind of program opens our eyes to how things are... it's nice to know we are not alone."






